By-Law No. 2008-01

FIRST NATION RATES BY-LAW

WHEREAS pursuant to the *Indian Act*, R.S.C. 1985, and specifically paragraph 83(1)(a) of the *Indian Act*, 1985, c. 1-5, the Council of a band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose:

AND WHEREAS the Council of the Whitecap Dakota First Nation (also known as the Whitecap Band) enacted the Whitecap Dakota First Nation Property Assessment and Taxation By-law on August 12, 2005;


NOW BE IT HEREBY RESOLVED that the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act*, and in particular section 83(1) for the purpose of establishing annual rates of taxation.

1. This by-law may be cited for all purposes as the Whitecap Dakota First Nation 2008 Rates By-Law.
2. Pursuant to Section V of the Whitecap Dakota First Nation Property Assessment and Taxation By-law, the tax rates for each class of property shall be in accordance with Schedule "A" that is attached, and forms part of the 2008 Rates By-law.


