**MILLBROOK FIRST NATION
2000 RATES BYLAW**

WHEREAS pursuant to subsection 83(1) (a) of the *Indian Act* the Council of a band may make bylaws for the purpose of taxation for local purposes of land, interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters rising out of or ancillary to such purpose:

AND WHEREAS The Council of the Millbrook First Nation, enacted the Land Tax By-law on June 3, 1996.

NOW BE IT HEREBY RESOLVED that the following bylaw is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

1. This bylaw may be cited for all purposes as the Millbrook First Nation 2000 Rates Bylaw.
2. Pursuant to Section 11 of the Land Tax By-law, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the 2000 Rates Bylaw.

APPROVED AND PASSED at a duly convened meeting of the Millbrook First Nation held at the Millbrook Band Administration Office, 835 Willow Street, Truro, Nova Scotia, this 30 day of June, 2000.
