**TS'IL KAZ KOH**

**ANNUAL RATES BY-LAW, 2024**

**WHEREAS:**


- A. Pursuant to the *Indian Act*, R.S.C. 1985, and specifically paragraph 83(1)(a) of the *Indian Act*, 1985, c.I-5, the council of a band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose; and
- B. The Council of Ts'il Kaz Koh enacted the Burns Lake Band Property Assessment By-law and the Burns Lake Band Property Taxation By-law, on or about May 26<sup>th</sup>, 1994,

**NOW THEREFORE** the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act*, and in particular section 83(1) for the purpose of establishing annual rates of taxation.


1. This by-law may be cited for all purposes as the *Ts'il Kaz Koh Annual Rates By-law, 2024* ("**Rates By-law, 2024**").
2. Pursuant to Section 18.1 of the *Burns Lake Band Property Taxation By-law*, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the Rates By-law, 2024.

**THIS BY-LAW IS HEREBY DULY ENACTED** by Council on the 29 day of July, 2024, at the Ts'il Kaz Koh Office, in the Province of British Columbia.
