SKWLĀX TE SECWEPEMCÚĽECW ANNUAL TAX RATES AMENDING LAW, 2024

WHEREAS:

- A. Pursuant to section 5 of the *First Nations Fiscal Management Act*, the council of a first nation may make laws respecting taxation for local purposes of reserve lands and interests or rights in reserve lands, including laws authorizing the expenditure of local revenues;
 - B. The Council of the First Nation has made a property assessment law and a property taxation law;
- C. Subsection 10(2) of the *First Nations Fiscal Management Act* requires a first nation that has made a property taxation law to, at least once each year, make a law setting the rate of tax to be applied to the assessed value of each class of lands and interests or rights; and
- D. The Council of the First Nation enacted the *Skwlāx te Secwepemcúlecw Annual Tax Rates Law*, 2024 and now wishes to amend that law.

NOW THEREFORE the Council of the Skwlāx te Secwepemcúlecw duly enacts as follows:

- 1. This Law may be cited as the Skwlāx te Secwepemcúlecw Annual Tax Rates Amending Law, 2024.
- 2. The Skwlāx te Secwepemciilecw Tax Rates Law, 2024 is amended by deleting the Schedule to that law and replacing with the Schedule attached to this law.
- **3.** Except where otherwise defined, words and expressions used in this Law have the meanings given to them in the *Skwlāx te Secwepemcúlecw Annual Tax Rates Law*, 2024.
- **4.** This Law comes into force and effect on the day after it is approved by the First Nations Tax Commission.

THIS LAW IS HEREBY DULY ENACTED by Council on the 12th day of December, 2024, at Chase, in the Province of British Columbia.

A quorum of Council consists of two (2) members of Council.
